The council is part of the ABA's Appellate Judges Conference and is the first and only national appellate bench-bar organization, according to the ABA's website. It's stated mission is to improve appellate advocacy by promoting dialogue between appellate lawyers and judges.

Pauley said in a release:

"I'm honored to be named Chair-elect of the Council. I look forward to working with my fellow members to create programs and opportunities for judges and lawyers to work together in furthering the organization's mission of enhancing the quality and integrity of the appellate process."
